3 airlines to merge with Air India

Mumbai : Tata Sons is gearing up for the expansion and strengthening of Air India, which it acquired a few days ago. Tata Sons has decided to merge three companies namely Airlines Vistara, Air Asia and Air India Express into Air India. Sources informed that the process has started and an official announcement will be made soon. If this plan of Tata Sons is successful, Air India will become the second largest airline in the country in terms of fleet and market share. Singapore Airlines is a partner of the Tata Group. Tata is in talks with Singapore Airlines about this.

Tatas have discussed this with Singapore Airlines and have agreed to merge Vistara with Tata. Singapore Airlines is an expansion partner of the Tata Group and after this merger, Tata Singapore Airlines, which operates the expansion, may merge with Air India. Air India will be a low cost full service airline. An official announcement about this can be made within a week. Both airlines may resume commercial operations soon. But it may take more than a year to start working as an organization, sources said. Vistara and Air India may resume commercial operations soon. However, Tata Sons and Vistara have not given any official comment on this as of now.
