Tata Sons has decided to merge three companies namely Airlines Vistara, Air Asia and Air India Express into Air India. Sources informed that the process has started and an official announcement will be made soon. If this plan of Tata Sons is successful, Air India will become the second largest airline in the country in terms of fleet and market share. Singapore Airlines is a partner of the Tata Group. Tata is in talks with Singapore Airlines about this.
